## Swimming Pool Cleaning and Chemical Service

QUALITY POOL CARE, INC. will furnish all labor and equipment necessary to perform the services itemized below. The options available are:

### OPTION #1 – Full Service Call with Chemicals

1. Test and adjust pool water chemistry.
2. Clean skimmer basket(s)
3. Clean pump strainer basket(s)
4. Clean and check automatic cleaner
5. Fill & adjust Chlorinator
6. Check filter pressure and clean if required
7. Hand skim surface
8. Vacuum – **If needed**
9. Brush walls
10. Prepare written report & leave copy with owner or lessee

### OPTION #2 – Chemical Service Call with Chemicals

1. Test and adjust pool water chemistry.
2. Clean skimmer basket(s)
3. Clean pump strainer basket(s)
4. Clean and check automatic cleaner
5. Fill & adjust Chlorinator  
Prepare written report & leave copy with owner or lessee

**\*\*\*\*\* For our valued customers, we are offering the opportunity to pre-pay your service season at a 5% discount, affording you both convenience and economy. \*\*\*\*\***

***Reminder: All additional repairs or replacement parts necessary will be billed in addition to this offer.***

The charge for the foregoing service is shown above. The price per visit shown above includes all federal, state and local taxes. Any return visit(s) for repairs will be billed at our current service call rate of \$30.00 per 15 minutes. Any and all complaints are to be reported by the customer to our office within 24 hours of the service to allow Quality Pool Care, Inc. the opportunity to resolve such matters. After September 1<sup>st</sup> an additional charge may be applied if excessive debris is in the pool. This will be billed at the rate of \$120.00 an hour, charged in 15 minute increments after the first hour.

**QUALITY POOL CARE, INC.** will carry in full force Public Liability & Property Damage Insurance in addition to Workmen's Compensation Insurance as required by law.

**QUALITY POOL CARE, INC.** will begin the service chosen below, the week following your pool summerization and will continue weekly through your pool winterization, unless otherwise instructed. The work will be done on the assigned day or days if weather permits.

This amount will be billed at the end of every month and is due upon receipt of bill. If payment is not received by the 20th of the month, services will be SUSPENDED until receipt of payment.

**This proposal will become a contract when the original copy is signed by the Owner/Lessee and returned to QUALITY POOL CARE, INC. within 30 days of the proposal date. The contract may be canceled by either party at any time during its term upon ten days written notice prior to the date the service is to be discontinued.**

**Work will not be scheduled until a signed contract has been received by QUALITY POOL CARE, INC.**

**Note:** This is contingent upon the owner's keeping the pool piping, motor, pump, filter, and interior pool finish in good repair. It is the customer's responsibility to maintain proper water level. Quality Pool Care, Inc. will not adjust the water level.
